Weed Control

The table below shows all weeds that are fully susceptible to 30 g/ha Kaskad with a suitable tank mix partner such as either 1.1 L/ha phenmedipham containing 160 g/L phenmedipham or 1.1 L/ha phenmedipham and 0.5 kg/ha metamitron containing 700 g/kg metamitron.

Product Performance

Trials in the north of France with Kaskad and Debut have been looking at crop safety as well as comparing weed control.

Both products are being used at 20g/ha and 60g/ha in mix with an adjuvant and the products shown opposite and applied at 2, 4 and 6 leaves of the crop.

The graph below shows no significant differences between the two products for weed control.


Even at the higher use rates of 60g/ha no phytotoxicity was seen in the trial.
